Los Angeles County Department of Public Health Non-Exhaustive List of Prohibited Flavored Tobacco Products

Revised: October 15, 2024

This non-exhaustive Flavored Tobacco Products list is produced to facilitate compliance with and enforcement of the County of Los Angeles' prohibition on the sale of flavored tobacco products [Los Angeles County Code (LACC) § 11.35.070(E)]. This document supersedes previously released lists produced by the Los Angeles County Department of Public Health (Public Health). The Flavored Tobacco Products List includes tobacco products that Public Health has determined to be flavored based on its labeling, packaging, marketing and/or aroma, pursuant to LACC § 11.35.020(C)(J). Flavored tobacco products on this list are prohibited (banned) from being sold in unincorporated areas of Los Angeles County. Possession of flavored tobacco products for personal use is permitted.

The County ordinance prohibits the sale of the following types of flavored tobacco products, including but not limited to:

- Menthol cigarettes
- Flavored electronic smoking devices (e.g., electronic cigarettes, electronic cigars or cigarillos, electronic hookah, vaping devices, including tobacco-free and nicotine-free vapes)
- Flavored e-juice/pods
- Flavored cigars, little cigars, and cigarillos
- Flavored smokeless tobacco (e.g., chewing tobacco, dip, snuff, snus, nicotine pouches and dissolvable tobacco products)
- Flavored wraps (e.g., tobacco wraps, blunt wraps, hemp wraps, rice paper wraps, etc.)
- Flavored loose-leaf and roll-your-own tobacco
- Flavored hookah/shisha tobacco
- Tobacco product flavor enhancers (e.g., flavor cards, wraps)

Below is a non-exhaustive list of flavored tobacco products that are prohibited (banned) from being sold in unincorporated areas of Los Angeles County. The list includes tobacco products that have been determined by Public Health to be flavored but does not include all flavored tobacco products:
